How much are your loan amounts?

Business to consumer loans start at \$100,000 and are approved at approximately 33% of annual sales. Asset Based loans range from \$100,000 to \$15 Million. Growth funding (B2B or B2G) loans typically range from \$100,000 to \$10 million but can go larger. Business acquisition funding is from \$1M to \$5M and are approved at 1.1 debt service. Trade Finance programs typically range from \$1 million to \$20 Million. These are all ranges and every deal will be underwritten on it's own merits.

What can you use the money for?

Typical use of funds include business acquisition, franchise expansion, renovations, remodeling, new equipment purchases, financing newly awarded contracts, inventory, advertising and marketing, or to simply stabilize cash flow.
